334) Apologies. Councillors P. Prosser, S. Rees, J. Thomas, S. Trollope and I. Wood

It was with deep regret that Members heard the announcement of the sad passing of Paul Flynn, M.P. Paul was a true man of the people - showing dedication and continuous support to the community in which he lived, particularly as Labour's longest serving Member of Parliament. The tributes from everyone in Newport had been extremely touching since his passing; he would be greatly missed, not only by Tredegar Town Council, but the area of Newport as a whole.

It was agreed that the appropriate letter of condolence be sent to his constituency office.

335) Declarations of Interest

The Chair reminded Members to make their declarations as and when necessary: Council M. Cross declared an interest in a planning matter.

336) To receive any verbal recommendations of the Policy Sub-Committee held immediately prior to this meeting

The following recommendations arising from the Policy Sub-Committee were presented for consideration and approved accordingly.

- Risk Management Policy and Standing Orders: Clerk to undertake amendments and re-circulate, with the option for Members to approve or re-agenda, if necessary.

Members thanked the Officers for updating the Policies and outlining the in-depth list of amendments.

337) Accounts: to consider a Schedule of Accounts for payment in February 2019
The RFO spoke to the report and explained that the bank reconciliations were available for Members to view.

Schedule of Accounts

- Christmas Lighting replacement cheque issued to reflect reduction for breakdown in services. There also had been expenditure incurred for the removal of infrastructure following the request of the owner of a number of business properties in Tredegar.
- STAR now operating as Sirhowy Community Centre Limited.
- Cenin Renewables site visit payment process agreed. It was agreed that the pick-up/drop off point would be the shopping precinct bus stops.
- Town Clock surround it was agreed to waive financial regulations in respect of the supply of plants for the Town Clock garden surround REASON: to ensure quality of plants. The RFO asked that Prices' of Beaufort be agreed, as their prices had been very competitive over previous years, had been most helpful in responding to queries, and were happy to liaise direct with the gardener for the plants to be delivered on site; there was also no charge for this delivery service. This was agreed accordingly.

There being no further queries regarding the Schedule of Accounts, all presented items were approved for payment. Transfer of funds would be undertaken in the presence of the appropriate Member and Town Clerk, which was noted accordingly.

A Member expressed serious disappointment in the lack of consultation with the Town Council, and sporting organisations. expressing concern that the Local Authority had not arranged to meet prior to considering recreational changes in the town. The Charter was a legal document that outlined the importance of consultation, e.g. recreational facilities. No consultation had been undertaken with County Borough Members or the Town Council.

It was therefore agreed that a letter be sent to the Leader of the Local Authority, with copies to the Ombudsman and Julie Lewis, challenging the Local Authority in the manner the proposed asset transfer of recreational facilities had been undertaken and the nonadherence to the Charter, which was a legal document.

- A. Parker Re: Welsh Government Consultation on improving Public Transport. Closing date for comments 27.03.2019.
 - Noted; this was an ideal opportunity for Members and the public to highlight the lack of a bus service from Tredegar to Ebbw Vale Hospital; this was a concern as individuals were paying significant taxi fares in order to visit loved ones in Ysbyty Aneurin Bevan – particularly the elderly and those with mobility difficulties. Another Member raised an issue of the bus route, which he suggested could easily be diverted to stop at Morrison's and Ysbyty Tri Chwm to continue to Ebbw Vale

Also, the withdrawal of funding from Caerphilly CBC which would impact on the service from the bus station to Cefn Golau.

A brief discussion thereupon ensued regarding the possible rise in taxi fares due to increase licensing fees, whereupon a Member suggested that the bus pass could be recognised as part-payment for taxi fares.

It was therefore agreed that the Link be placed on TTC website for the public to access.

A Member raised concern of the issue of four-wheel drive vehicles, buggy / quads, and motorbikes scarring the landscape at Trefil and animals allowed to run unrestrained. Members totally supported these concerns that the landscape was being destroyed in this area, which formed part of the National Park. It was agreed that a letter be sent to the National Park Authority, outlining concerns and supporting any joint venture that could be undertaken by the NPA and Police.

Members were also informed of a similar problem at Mynydd Manmoel in respect of

use of off-road vehicles, whereby concerns were being investigated by the Planning Officers of the Local Authority.
