**d) Tredegar Twinning** – the meeting had been held Monday; unfortunately, the House had been closed so the Association had needed to use a different venue. The Secretary had written to the Moose to use as the host venue at 12.00 noon on the Saturday and enquired, if a charge was levied, would Town Council contribute.
