 Free Wi-Fi for Tredegar – in response to a query, the Clerk confirmed that a Blaenau Gwent Officer had made a presentation to Council in respect of the provision of free Wi-Fi for Tredegar town centre, to ascertain interest of Council to provide financial support; however, this was sought in principal as the project progressing was dependent on certain circumstances, i.e. relating to Brexit.

The project had since been confirmed and Tredegar Town Council had agreed to a commitment of £2,000 per year for two years. A Member was aware that installation of equipment had commenced but was not aware if the Wi-Fi was live / active as yet.

The Member welcomed the information and said that, when the launch date was known, this should be promoted accordingly. Another Member was aware that the Homepage was to be released soon, inviting individuals to submit links to their splash page.
