i. Boyer Planning FAO: Sirhowy Ward Members, Trefil Quarry Pre-Application Consultation. Reminder responses deadline is Friday, 7<sup>th</sup> January, 2022:

Trefil village residents recognised the important role of the quarry to the economy and also the opportunity to comment on any impact to this area, e.g. disruption and adverse impact to the highway due to larger / heavier lorries, from the roundabout to accessing the site; disruption in the vicinity of the Mountain Air Inn; development to Triple SSI sites and reinstatement of the environment on completion.

The Council's representative on the National Park Authority suggested that, although the application was at the pre-application stage, any correspondence sent should be copied into the Brecon Beacons NPA.

ii. BGCBC C/2021/0358 demolition of 23 and 24 Stocktonville Tredegar – reason for demolition, property not being up to current standards

#### 256) St. John Ambulance - Tredegar Branch: to discuss

Concerns had been noted in respect of possible closure of some branches of the St. John Ambulance. Following a brief discussion, it was agreed that Council write to ascertain the current status of the Tredegar Branch and Hall, as the organisation was a valuable asset to Tredegar, always supporting Town Council, and would be a substantial loss to the community.

A Member suggested that clarity be sought as to the reason if the Branch / Hall was to close as, if due to financial constraints, there were opportunities to share the premises – for example, the Scouts were currently looking for a venue.

Members noted the excellent activities undertaken over the Christmas period, often under difficult circumstances, to all ages and backgrounds: it was agreed that a letter of congratulations be sent.

Council agreed that more prominent signage was needed to promote that the public convenience were provided and maintained by Tredegar Town Council.

The Line Manager said he had arranged for the Cleaning Operative to remove the baby changing facilities from the Gents, as he had been informed there had been a safety issue; Clerk to ascertain if this action had been undertaken.

Members commended the ongoing toilet provision, considering this an excellent facility, maintained to a high standard.
