The Chair reminded Members to make their declarations as and when necessary.

Members recognised that the Public Facilities Sub-Committee could possibly consist of different Members and therefore suggested this be deferred until the end of May.

A brief discussion ensued regarding the immediacy of the need for pitch markings in order to accommodate more effective use of the facility and it was considered that Council should support these groups as much as possible.

It was therefore agreed that the pitch markings be approved temporarily for one month, subject to review following the meeting of the Public Facilities Sub-Committee, and subsequently meeting with group representatives.

Observations: Members raised a number of concerns in respect of the proposed development, i.e. lack of / no public consultation with the residents in the immediate and surrounding areas (as Members understood that such consultation had to be undertaken by law), e.g. Dukestown Road, St. Luke's Road and Armoury Hill; relocation of the play area currently used by the local children; no traffic calming measures included within the planning application.

d) To consider other planning matters - C/2022/0051 Two storey side and rear extension with single storey rear extension and roof terrace and patio area, Hughes Cottage, Merthyr Road, Tafarnaubach, Rhymney. *No objections* to the proposed build, however, concerns raised in respect of the substantial removal of soil on site and possible reprofiling, and subsequent construction traffic transporting materials through the site.

360) Matters of Local Interest or Concern (by prior notice)

- Beaufort Road; increased volume and speed of traffic there had been a number of fatalities on this highway and it was proving dangerous for pedestrians to cross; residents had complained of missing buses, due to being unable to cross safely. It was agreed that Council request a site investigation to be undertaken to look at pedestrian access as a matter of urgency.
- Public Conveniences a concern had been raised that the toilets had not been opened on Good Friday over the Bank Holiday weekend; also an incident on one occasion when Fresh Active had forgotten to unlock the toilets initially. Therefore, there was a need to find a long-term solution for the unlocking of the toilets when the Member keyholder was

unavailable. Agreed; refer to the Public Facilities Sub-Committee.

Councillor David Howells said that having been on Council for eighteen years, it was time to step down. It had been a privilege to represent the people of Tredegar and he particularly proud of what we had done over the years, for example, over the last twelve years with Armed Forces Day, Aneurin Bevan Day and Festival, Deighton playing field and the toilets. Also the Cenotaph and the Town Clock, and year-on-year improving the Christmas Lights of the town, and the work every Councillor had done for the town, for no payment. He had enjoyed himself on the Council, which had been like a family – and like family, do have disagreements – and after all was sorted, it was beneficial to the residents for these disagreements. He had made plenty of new friends on Council and in the community.

"Thank you all and I wish Council and the staff the best for the future."

Members thereupon paid credit to Councillor Howells, who had been a credit to Central and West, and to the other Members not standing in the forthcoming Election. He considered this one of the best terms since becoming a Councillor in 2004, with more work done in this time to help the people of Tredegar.

Well done to Councillor Tommy Smith, as Leader, and Councillor Alyson Tippings as Deputy Leader. To all – Tommy Smith, David Howells and Bernard Willis – a credit to the Council, 'Thank You'.

Councillor David Jones said he had thoroughly enjoyed his time as Councillor, particularly the refocus during Covid, extending thanks for the camaraderie and the experience.

Councillor Tommy Smith echoed the sentiments expressed by Members, he extended his thanks to all Members and staff. It had been a privilege to serve as a Member, as Mayor, and Leader since 2014; he offered thanks to Councillors Bernard Willis, David Howells and David Jones – "Thanks for all you have done". He extended 'well wishes' to all returning Members and the very best for the future and said if he could be of any support to Tredegar Town Council. He wished all Members well standing for the forthcoming Elections on 5th May and a "Thank you" to the Chair for the last year, as chairing was not always easy.

A Member wished to thank Members, considering this sad and emotional, as an end of an era for many:

Thanks to Bernard Willis, although crossing swords on occasion, for his wry sense of humour and service to Town Council, lots of work in respect of public facilities, advice and knowledge, public toilets and other facilities in Tredegar – wishing him a happy retirement.

To David Jones, for marking her homework with his 'red' pen and the knock on the door, a great Governor at Bryn Bach Primary and was always happy to help out at events, providing a great service to this Council.

To David Howells, the longest service to the people and now retiring. He had been a loyal Member, and one of the key things being his local knowledge and having his finger on the pulse - although standing down, he could continue to feed back news. He also had been a Governor at Bryn Bach Primary and supportive of Town Council Governors, doing an amazing job in primary schools.

To Councillor Malcolm Cross, who was unfortunately poorly at present. For his excellent local knowledge, particularly historical elements of the town, and supporting activities; for being Governor on both Bryn Bach Primary and St. Joseph Primary Schools; and always being there to help, particularly in transporting the steps and road signs. The

Member wished him a speedy recovery – "Thank you for your service."

To Tommy Smith, her 'wingman' for the past five years, as many would not realise the work he done; virtually every day liaising with the Clerk and as the first point of call. This was not easy as he did not drive and needed to walk to town or get a lift. "Thank you very much for what you do in the Council."

The Mayor said 'thank you all very much for your time' and how much time Members needed to spend with each other; it had been a "great pleasure working with you all".

 A Member presented a nomination for an Award for consideration of Council, which was agreed accordingly – the Member would complete the Nomination Form required and return to the Clerk to be retained.

The Mayor wished those retiring all the best and, for the forthcoming Elections, the best of luck. There being no other business, the meeting closed at 7.35 p.m.
