- The gateway signage at Trefil had been erected; it was therefore agreed that an official opening be convened with a photoshoot opportunity. It was suggested it would be nice to invite the youngest and oldest residents in the village to attend, both Town Council and County Borough Members for Tredegar, and appropriate civic dignitaries. The Chapel would be available for the provision of light refreshments; the expenditure was thereupon approved accordingly.
- The X4 bus service was to be replaced with the T4 from Tredegar to Merthyr, whereby passengers would be subject to wait three quarters of an hour to continue their journey. This was a much-used link from Tredegar to Abergavenny, Merthyr and Hereford, and it was agreed that Council write to Stagecoach in this respect.
- The road closure signs previously stored in the lock-up had been left outside, which could be stolen and were subject to the elements; these signs needed to be locked away as soon as possible.

A Member said that a stocktake needed to be undertaken to review the quality, as some were not fit for purpose and needed replacing.
