The Chair reminded Members to make their declarations as and when necessary.

The Chair extended a welcome to the Local Places for Nature Officer, Ms. Rachel Carter, who had requested an invite to attend a meeting of Council to update Members on the work being carried out.

Local Places for Nature 2022 / 2023

- To create... 'Nature on your doorstep'.
 To restore and enhance nature where people live, work and access public services focused on:
 - ➤ Areas of deprivation
 - ➤ Urban / peri-urban areas
 - ➤ Places / people with little or no access to nature
- Rationale:

If people were able to engage with nature where they live, work and access public services, they were more likely to value it; to support wider initiatives, and spending; to support work to restore and enhance nature and the environment on a larger scale. Exposure to nature had associated wellbeing benefits.

The public sector would lead by example and showcase change [Biodiversity Action Plan / Section 6 duty (Environment Act 2016) / NRW Area Statements / Well-being act 2015]

- Projects needed to fit in with the First Minister's commitment to 'modest measures...
 things that make an impact locally'
- Local Places for Nature Scheme Managers

£2m - National Lottery Heritage Fund Capital offered capital grants £10,000-£250,000. Town and community councils could submit a project that met the criteria (feedback and support available prior to submitting an application)

£1.9m – Keep Wales Tidy offered packages to create Nature Gardens. Starter or Development packages: all resources provided and the support of the local KWT Project Co-ordinator, providing plants, fruit trees, wildflower turf, greenhouse, tools and expertise.

£5m - Pan-Wales Local Nature Partnerships. 25 Local Nature Partnerships across Wales; Each local authority had a dedicated LNP Co-ordinator who was a biodiversity expert who could advise on your project.

NEW Orchard Package: create an orchard - 12 fruit and nut trees, 2 benches, 10 pairs gloves, 320 Bulbs, water butt, 2 orchard books, Habitat boxes – 2 bug hotels, 2 hedgehog boxes, hand tools (2 pruning saws, extendable loppers, bulb planter, 2 secateurs, 2 rakes, wheelbarrow)

The representatives thereupon responded to Members' observations / questions raised:

- Support included help with projects, advice, a designated co-ordinator the BG Co-ordinator was Veronica Branniwich

The Chair extended the thanks of Council to the Officer for the comprehensive update, which had been very knowledgeable and greatly appreciated, and was sure Council would remain in contact in the future.

The OVW Local Places for Nature representative thereupon left the meeting.

127) To receive Mayor's report, as appropriate

The Mayor had visited Bedwellty Park Bowls Club, with the Leader also in attendance; the sun was shining as he met with the ladies' team and enjoyed a game of bowls. He had also attended the Queen's Award for Voluntary Services at The Moose hall, with Councillors Kevin Phillips, Jacqueline Thomas and Mark Turner; he had a photo taken with the Lord Lieutenant, and it had been a very good night. The Mayor had attended Merchant Navy Day, again with the Leader, and a few Members. Reverend Matt Davis gave a very good Service, which was well appreciated by all those who attended.

The Mayor informed Council he had been elected as Executive Member to the OVW Communications Commercial Committee. He had also attended the Police surgery in the town, together with Councillor Haydn Trollope - he and the Mayor had been the only two people in attendance and he expressed concern why the public did not attend. There was two CSOs there to take messages back; the venue was absolutely unsuitable, being an open plan building, with people in the gym next to the building, the public would be unable to speak privately / confidentially; therefore, this was not conducive for speaking to the Police. Apparently there were issues on Facebook, i.e. threatening messages.

In respect of the Mayor's Blog, the Member would liaise with the RFO.

134) Matters of Local Interest or Concern (by prior notice)

Drug issues - Town Centre / Police Station: the Chair had been asked by members of

the public to investigate issues in respect of drug dealing in the town centre and the shopping precinct. He had actually witnessed an incident of an individual selling drugs and reported this to the Police, who had asked for evidence. The Member had obtained a photo of the individual dealing drugs in the morning to a young girl at the precinct gates. He had been unable to gain access to the Police Station to report the matter and there was no answer at the door. He telephoned '101' – waiting thirty-four minutes to be connected and was then told to place the concern in writing. Two 'plain clothes' Officers, on entering the building, informed him the Station was unmanned – the only manned Station in the borough was Ebbw Vale, Monday to Friday, 9.00 a.m. to 5.00 p.m.

The Chair had written to the Police and Crime Commissioner outlining the problems in respect of the Police Station and the drug dealing in the town, seeking a meeting and asking him to take action. He had received a response a week later, informing the Member that the matter had been referred back to the Sergeant.

On speaking to Councillor Haydn Trollope - he was told that, at a meeting, it had been claimed that the crime rate in Ebbw Vale was greater than in Tredegar and therefore it was more important that there be an 'in front of' Officer at Ebbw Vale Police Station. The Chair said that the inhabitants of Tredegar should have the same right to access their Police Station and therefore asked Chair to consider moving the following proposal – to be transmitted to Blaenau Gwent County Borough Council and the Crime Commissioner (Councillor J. Thomas thereupon declared an interest, being a member of the Police and Crime Panel, and took no part in the decision)

- "That Tredegar Town Council deplores the fact that the services provided at the town police station are not equal to that of the neighbouring station in Ebbw Vale, which has staff available Monday to Friday to take complaints from inhabitants of the town. This Council resolves to take whatever action is required to achieve parity and believes that the inhabitants of Tredegar are being discriminated against."

A Member said that a meeting with the Police and Crime Commissioner would be totally unbeneficial as he had no control in respect of operational matters and perhaps Council should only pursue a meeting if the Chief Constable attended also. The issues communities faced were 1) did not share the same priorities, and 2) under-staffed and under-funded.

Another Member stated that Council had fought the closure of satellite offices, but she was of the opinion she would prefer resources be used for a presence on the streets, as previously the main function was for individuals' 'bail check'. A Member suggested that the thoughts of Council could be relayed to the local M.P. for support.

It was therefore agreed that the proposal, as presented, be forwarded to the Police and Crime Commissioner.

 Events Sub-Committee: as Council did not wish to participate in the Open Doors event, a meeting could be held prior to the next meeting of Council.

There being no other business, the meeting closed at 9.00 p.m
