Observations; a number of Members considered this development would result in a saturation of this business type. Also, generally takeaway establishments opened during the evening and, therefore, the shutters would be down whilst other retail premises were open, thus detracting from the appearance of the town. It was acknowledged that a more diverse cross-section of business-type was needed to support vibrant retail, e.g. delicatessen, bakery, zero waste, etc. A Member highlighted, however, there was limited interest on what type of shops currently seemed to be attracted to the Tredegar area.

151) Matters of Local Interest or Concern (by prior notice)

- Recycling the concern related to the Newvale site, however, this had now been resolved.
- Tredegar Gateway feature the wall at this gateway feature on the Crown roundabout had been demolished for many years; the Town Council had previously reported this concern to the Local Authority on numerous occasions: Clerk to write and follow up; and, also propose as agenda item for the next meeting of Joint Councils.
- Town Centre walkway the walkway was in disrepair; it was acknowledged that the Business Forum had provided and maintained planters and the TC contractual operative undertook a litterpick in this area. Clerk to write to BGCBC.
- Public Conveniences the issue of additional named keyholders remained; Clerk to write to all Councillors.
- Queen's Commemoration Proclamation service a Member expressed concern that the timing of the event had been arranged to accommodate the Assembly Member, rather than Tredegar Councillors; it was felt there would have been a better contingent of Town Members if the event had been held early evening and the Member expressed her disappointment. The Leader said the matter had been discussed with the Deputy Leader and Clerk and she had suggested there was a need for the Proclamation reading to be undertaken in Welsh; therefore the A.M. had been invited to undertake this. Councillors said there was other Welsh speakers residing in the Tredegar area that could have been invited to undertake the reading on behalf of Council and the commitments of Town Councillors should have been considered for Members to attend.
- Cattle there was a large herd of Highland cows grazing in the river area at the lower end of Tredegar / Bedwellty Pits. Pedestrians / walkers were being forced to choose another route due to these animals blocking the pathway. The Member enquired if the owner could legally leave these animals to graze in this area, deterring users and leaving an absolute mess on the pathway. Following discussion, it was agreed that the
