- 5) Gwent Police Tredegar Neighbourhood Policing Team: looking to hold a fun / education event for children of all ages on / around 12th August, asking to use Deighton playing field, for approx. four hours
 - In respect of allowing parking of emergency vehicles on the playing field, concern was expressed in respect of the weight of the vehicles and damage to the surface; however, Members wished to support the event.

Following discussion, it was agreed therefore that Council would allow use of the Deighton playing field but the 'emergency services'

	vehicles to be parked on the tarmac drive alongside the field and pop-up stalls <i>only</i> to be allowed on the pitch itself.
	 Agreed; Clerk to respond and provide the criteria for appropriate use of the facility. i.e. Vehicular access was through the main gates. No vehicles to be driven or parked on any grass areas; vehicular movement was prohibited, as this could prove a danger to users. Access to the emergency services vehicles only and gates locked to prevent any further vehicles accessing the area. Any equipment / banners / promotional materials to be removed and litter collected at the close of the event. Gates securely locked once field vacated. Conditions were in place so that the area was kept in a good safe condition for the community groups currently using it.

C/2023/0108	Mr. Shailesh Verma Ambay Service Station Willow Court Nantybwch Tredegar NP22 3SF	Proposed development at: Ambay Service Station, Willow Court, Nantybwch, Tredegar – Proposed alterations and extension to existing Texaco Petrol Service Station building to provide additional retail space at ground floor level and ancillary staff accommodation and storage facility at first floor level

Observations: Council expressed concern in respect of the length of time for this proposal to come forward after work had commenced and the manner in which this was being undertaken, e.g. the lintel being balanced on a brick, which could prove hazardous and was an issue of concern. Also, the car washing service provided on this site: the spray was all over the footpath, which was a safe route for school, and became icy during inclement weather; also, members of the public could be subjected to a blast of water. If the applicant was improving the building, the car wash should be looked at to raise the site to a desirable standard.

This was the entrance to the town, and a refuelling point on the Heads of the Valleys road – the roundabout was not maintained to a particularly high standard, the stone wall was damaged and partially demolished, and Council considered this represented a poor gateway for the area.

Members also referred to the reference to 'staff accommodation' and emphasised the importance of ensuring this was not in respect of sleeping accommodation but office provision only, as Council recognised the high risk due to flammable products.

Council welcomed the upgrade to the building and also the provision of the public facilities, which was needed for motorists during a journey.

035) One Voice Wales: Motions for 2023 Annual General Meeting

Discussion ensued regarding the disruption by illegal motor vehicles within town centres; the registration of such vehicles would allow the Police to confiscate if the owners were proven of breaking the law.

Approved – one motion: "To lobby Governments that all vehicles, i.e. quads and motorbikes, be registered with a Registered Vehicle Identity Number to arm the Police with sufficient information to identify the vehicle / rider on reporting and enable confiscation."

036) Matters of Local Interest or Concern (by prior notice)

- Line Management the Leader had spoken with staff and confirmed that arrangements were now as follows: Clerk to line manage the RFO, gardener and cleaning operative; and, Leader to line manage the Clerk.
- Dilapidated state of repair; play area, top entrance to Bedwellty Park a Member asked could Council make a request to Aneurin Leisure to consider upgrading / improving the play area. It was emphasised that this area was difficult to police as there was so many points of access and the area had been vandalised each time any damage was fixed.
- Stationary Bike the Chair said that their counterpart film company in California were visiting and, in celebration of his life, Ryan Probert's mother had requested a special showing of 'Stationary Bike. This was to be held at the Little Theatre on Saturday, 17th June, 2023 at 4.00 p.m. and Members were invited to attend; the Chair asked that

responses were forwarded direct to him in order to ascertain numbers in respect of refreshments.

Band stewards – the Clerk reminded Members that stewards were needed to set up the equipment / transport the bottled water. At the request of a Member: it was agreed that the concert on Sunday, 9th July, 2023, proceed, in part, as a singing festival, as requested by Abergavenny Borough Band.
