165) Declarations of Interest

The Chair reminded Members to make their declarations as and when necessary:

166) To receive Mayor's report, as appropriate

The Mayor said the Mayor's Charity Concert had reached the threshold for the concert to proceed, with the sale of an excess of one hundred tickets, currently raising £820.00 and approximately a further £200.00 as a result of the raffle. The Mayor said it would be nice to see everyone there who had purchased tickets for this 50^s/60^s Dance.

Leader's update -

The Leader had met with staff and their Union representative in respect of subtle changes to contract, e.g. slight change to working hours to accommodate meetings until 7.00 p.m. for working Members, and allow staff a late start in lieu, to avoid the practice of the same Members making all decisions;

Placing a permanent board in the Clock garden, whereby removable inserts could be placed promoting various events to inform the public, and prevent items being placed on the railings / the Clock, perhaps a collapsible design which could be stored inside the Clock;

- 3) EDPR Re: Mynydd Bedwellte Wind Farm proposals. Would like to meet with Council to discuss the proposals.

 Members expressed disappointment of the timing of the sessions, being between 9.00 a.m. and 5.00 p.m., excluding those working in the day. It was raised that Tredegar Town Council should be involved in considering how monies were invested in the community.

It was agreed that an invitation be extended to EDPR to attend a formal meeting of Council.

- 4) Property 4 Re: Complaint, Central Baptist Church. Copy of letter they are sending outlining their opposition to the activities and states this is their final warning to relocate away from the shopping centre.
 - Noted.
- 5) Coach & Horses Request for Council to consider buy and installing a defibrillator at the public house; have checked locally at both the nursing home and hairdresser but neither have one.
 - While Members supported investing monies by providing defibrillators in the community, it was suggested more were needed on the outside of buildings for access 24/7.

Agreed to defer; pursue with Ambulance Service.

Councillor A.E. declared an interest in respect of the following item and took no part in discussion or voting thereon.

- 6) Financial Matters: a) A.E. Tippings Re: Horeb & Sardis, Harvest Thanksgiving and Flower Festival. Invite to the Harvest services in Trefil. If Council wishes to sponsor a floral display, this year they will be £40.00. This year's proceeds from the Flower Festival will be donated to the Alzheimer's Society.
 - Expenditure approved.
 - b) Tredegar Comprehensive Re: Presentation Evening 19th October, 2023 at 6.00 p.m. Invitation for Mayor to attend and asking if Council wishes to sponsor the Aneurin Bevan, Michael Foot and Peter Morgan-Jones awards.
 - Members were disappointed that there was no mention of Council the previous year in respect of the Awards for Tredegar Town Council. The TTC representative in attendance on the night should be presenting the Awards on behalf of Council. It was noted previously the School had given the Mayor very short notice. It was

suggested if the TTC representative was not allowed to present the Awards, the cheques should be withdrawn, however; it was highlighted that the parents had been notified and this would not be fair to the pupils.

It was agreed that £50.00 be approved for each Award.

- A Member was sad to relay that the daughter of a previous TTC admin. staff member, Dilys, had passed away; the funeral would be held Monday. Member to obtain contact details in order that a letter of condolence could be sent.
- Congratulations were extended to Cameron Herring on his recent play for Wales, achieving the highest record for a Welsh cricketer; Member to research further details.
- A Member expressed serious concern in respect of the Arts Council for Wales funding cut for Blaenau Gwent - from £152,000 to zero - only two places in Wales were not receiving funding, Blaenau Gwent being one. This would have a massive impact on events for Heads4Arts and the Member suggested a letter be sent, stating how disappointed Tredegar Town Council were in respect of this decision, as he suggested it was short-sighted to remove this core funding, having a detrimental impact on arts in the valleys, and asking that the Arts Council provide justification and reconsider this funding cut.
