313) Declarations of Interest

The Chair reminded Members to make their declarations as and when necessary:

314) Mynydd Bedwellte briefing: to meet with representatives of EDP Renewables

The Chair extended a welcome to the representatives of EDP Renewables, who had requested an invitation to attend a meeting of Council to provide information in respect of the Mynydd Bedwellte Wind Farm proposal being brought forward by EDPR and respond to questions raised.

Councillor H. Trollope declared an interest in the agenda item and took no part in discussion or voting thereon.

- EDPR had been operating in the UK for ten years, providing renewable energy through provision of off-shore wind farms; office-based in Edinburgh. There were currently nine projects proposed for the UK, eight of which were in the early stages of planning.
- Mynydd Bedwellte Wind Farm was being proposed to provide clean energy across South Wales for homes and businesses; the representative outlined the megawatt to cost ratio. A Member suggested that wind farms were a far more welcomed source

of provision rather than nuclear power stations. Hydro-electrics projects were not feasible geographically as valleys would need to be flooded.

- Local authorities were statutory consultees throughout the process; Blaenau Gwent had been consulted in respect of the land option to ensure benefit to the community.
- Planning application to be submitted by 2025, group connection offer for 2028.
- Individual public consultations (x4) be held at various venues throughout the area; publicised on social media, local newspapers, over 7,000 individual invites two in New Tredegar, one in Tredegar and one in Ebbw Vale.
- EDPR had met with Blaenau Gwent CBC, the local Member of Parliament, the Assembly Member and now Town Council.
- EDPR to consult on deciding how best to reinvest potential monies for the benefit of the community.
- This was early in the development process and, at this stage, there was still a lot of work to be done to survey the views of the community.
- The lifespan of such projects had formerly been for twenty-five years, but this could now be extended to thirty, forty even fifty years. Manufacturers would look to changing gear boxes, etc. to extend the lifetime of the project.
- Training and job opportunities would be available at labour level, such as sponsoring
 of apprenticeships, working with local contractors, etc. especially in areas of new
 industry.

The Chair extended the thanks of Council to the representatives of EDP Renewables for attending and sharing this information, which was greatly appreciated. The representatives thereupon left the meeting at this juncture.

The Mayor said that the Leader had two updates for the attention of Council:

- The circuit box in the Town Clock should be locked and the electrics kept tripping; this
 issue needed to be resolved.
