**232) Declarations of Interest**

The Chair reminded Members to make their declarations as and when necessary.

**233) To receive Mayor's report, as appropriate**

The Mayor provided the following update on events:

- Diamond Wedding, Barbara and Duncan – congratulations to these lovely people, that Council know and love, who had been over-whelmed by the celebrations.
- Opening of MUGA at Tredegar Comprehensive School [Aneurin Leisure.]
- Christmas Lights switch-on – the display was beautiful; the event had been successful and Council was grateful of help by others. Lee had done a lovely job as Compère, if needed again, he wished to work with Council to make festivities bigger / better!
- Mayor Blackwood, Tredegar Orpheus Male Voice Choir - Louie Doel and Ellie Roberts were excellent. Poem, Patrick Jones, working with mental health charities to make a characteristic bridge, the site of many suicides, safer.
- Tredegar Orpheus Male Voice Choir - fund-raising concert in support of Cardiac Rehab.
- Cheque Cymru Creations – who were thriving in the town, offering help throughout Tredegar and working with the older generation.
- Ystad Deri Community Centre - one lady carrying operations, an absolute stalwart; surprised people attended all over – Tredegar, even Rassau, who came to events because nothing similar in their area.

- Otters Presentation – this was Sue Woodward's 47<sup>th</sup> year, starting six months after formed and was always joyful. When started, many of the disabilities related to Thalidomide, now the majority of people were on the Autism or Down Syndrome. The work was challenging, but lovely to support.
- Bedwellty Park Bowls - presentation cheque; the Club had an outstanding year, and next year would be special as their 50<sup>th</sup> anniversary; lots of events with the Bowls Barbarians, having secured promotion to the next league.
- Presented certificates to Window-Dressing competition winners - , these had been decorated / painted and it had been a lovely honour.

The works would require planning permission and Listed Building Consent. Subject to the handrail being of an appropriate design, material, finishing and fixing, and associated planning considerations as part of the formal application process, it was considered likely a planning application and Listed Building Consent application would be supported.

Re: Changes to Financial Services Compensation Scheme (FSCS). From 1<sup>st</sup> December 2025, the FSCS is increasing the maximum level of protection it provides, from £85,000 to £120,000, on eligible deposits. FSCS protection covers total eligible deposits across all the accounts held with Barclays, Barclays Business Banking, Barclays

Premier Banking, Barclays Wealth Management, and Tesco Bank.

Re: Powell's History of Tredegar. Just republished a very important literary work. Demand for book remains high, hence the decision to reprint, (100 copies printed). The Forum wonders whether Council may wish to obtain copies that could be distributed to local schools or perhaps could even arrange an official book launch?
